Midwest Conference Keynote Focused on "Repositioning Parks & Recreation"

Keynote learning experience supported through Landscape Structures' scholarship

The case will be made that an agency's long term viability will be dependent on how far along this evolutionary continuum it has progressed. The field's future lies in aligning with community priorities and engaging in activities that contribute to alleviating them. These were the key elements in the field's emergence as a public service in the late 1800s and early 1900s, and they remain central to its future viability.

The 90-minute session will be presented at 6 p.m. on Monday, April 15. Prior to and after the keynote address, delegates will have the opportunity to visit Dakota Fence and Landscape Structures in the exhibit hall to learn about the latest trends in playground design including custom and theme designs, playground and water play safety surfacing and creating truly inclusive play environments.
